School fees are paid either monthly or quarterly as per school calendar year.

1. Registration Fees new learners

- a) Grade R: R 750-00
- b) Grade 1-3: R 1000-00
- c) Grade 1-6: R 1000-00
- d) Grade 7: R 1050-00

2. Re-registration fees for old learners

- a) Grade 1-3: R550-00
- b) Grade 4-6: R600-00
- c) Grade 7: R600-00

4. Extra Costs

- a) Development fee: **R 450-00** per year.

5. FEES POLICY

NB: All foreign learners are expected to pay 50% of the fees on the first day of school academic year.

7. Payment Terms

7.1 Fees are due first day of opening for the 1st quarter.

7.2 Payments should be made timeously to avoid charges.

7.3 Once-off payments like re-registration, registration, sports fees, etc should be settled before commencement of term one every academic year.

7.4 Failure to keep accounts current will result in the accounts being handed over to the school Attorneys.

7.5 There is no refund for re-registration, registration, sports, development and school fees.

General

- **10% applicable for once off payment on School Fees, Registration Fees, Sports Fees and Development due on/before 31 January.**
- **For more than one child enrolled at the school no Development Fee will be paid for the youngest child enrolled at Maseala Schools.**

FAILURE TO PAY

The relationship that exists between the school and the parent is a commercial one based on a contractual agreement. Failure to pay school fees therefore is a breach of contract. This means the school is within its rights to terminate the contract. Failure to pay after the prescribed engagement will result in your child being excluded from school activities. We are a private school and as such reserve the right to admission. Parents will be advised to transfer /remove their child to a no fee-paying school.
